- Cityscapes will be considered, as long as the building is not the primary subject of the image. These images will be evaluated on a case by case basis.

- Professional photography is strictly prohibited without the written permission of the Chief or Senior Curators.
- Photographs are permitted for personal use only and are not to be published anywhere (including personal web sites) without the expressed written consent of the Museum.

- Located in Washington, D.C.
- Interior images of The Basilica of the National Shrine of the Immaculate Conception cannot be accepted without a property release.
- Exterior images of the National Shrine of the Immaculate Conception can be accepted.

[Beijing National Stadium \(Bird's Nest Stadium\)](#)

- Located in China.
- The stadium is a large steel structure used throughout the 2008 Summer Olympics.
- Isolated images of the stadium are unacceptable for commercial use.
- Images are acceptable as editorial with a newsworthy caption.

- Unacceptable for commercial & editorial use.

[Boston Public Library](#)

- Library buildings may not be used as setting for photographs or as a background for fashion models or advertisements which will be used for commercial purposes.
- Unacceptable for commercial use.

- Located in Dubai, United Arab Emirates.
- Unacceptable for commercial use.
- Cityscapes will be considered, as long as it is not the primary subject of the image. These images will be evaluated on a case by case basis.

[Burj Khalifa](#)

- Located in Dubai, United Arab Emirates.
- Isolated images of the Burj Khalifa are unacceptable for commercial and editorial use.
- Cityscapes will be considered, as long as the building is not the primary subject of the image. These images will be evaluated on a case by case basis.
- Images taken on the “At the Top” observatory may only be accepted for editorial use.

- The name of two amusement parks located in Virginia and Florida.
- Everything within the parks is protected and cannot be photographed for commercial use.

[30 St. Mary Axe \(aka “The Gherkin” and the “Swiss Re Building”\)](#)

- Located in London, UK
- Designed by Lord Foster, Ken Shuttleworth, and Arup engineers.
- Unacceptable for commercial use.
- Cityscapes will be considered, as long as it is not the primary subject of the image. These images will be evaluated on a case by case basis.

[Cadillac Ranch \(art installation\)](#)

- Located in Amarillo, Texas
- Created in 1974 by Chip Lord, Hudson Marquez and Doug Michels.
- Unacceptable for commercial use.

[Castel Meur](#)

- Located in North-Western France (Pointe du Château, Plourgrescant, Bretagne, France).
- Unacceptable for commercial or editorial use.

[Castle Ksiaz](#)

- Located in Silesia, Poland.
- A property release is required for commercial use.

- Editorial submissions will be considered with a proper caption.

[Castle of Chillon \(Château de Chillon\)](#)

- Located in Veytaux, Switzerland.
- Unacceptable for commercial or editorial use.

[Charging Bull \(art installation near Wall Street, NYC\)](#)

- Located in Bowling Green Park near Wall Street in New York City.
- Sculpture designed and owned by Arturo Di Modica.
- Unacceptable for commercial use.

[Christ the Redeemer \(“Cristo Redentor”\)](#)

- Located in Rio, Brazil
- Designed by French sculptor Paul Landowski
- Unacceptable for commercial use where the sculpture is isolated. Cityscapes will be considered on a case by case basis.
- Accepted for editorial use where accompanied by a proper caption.

[Chrysler Building](#)

- Located on the east side of Manhattan in New York City.
- Designed by architect William Van Alen for Walter P. Chrysler in 1928.
- Unacceptable as an isolated standalone commercial use image.
- Cityscapes will be considered, as long as the Chrysler Building is not the primary subject of the image. These images will be evaluated on a case by case basis.

[City of Arts and Sciences \(Ciudad De Las Artes Y Las Ciencias\)](#)

- An entertainment based cultural and architectural complex located in Valencia, Spain.
- Designed by Santiago Calatrava & Felix Candela and inaugurated in 1998.
- Unacceptable for commercial or editorial use.

[Chateau Vauvenargues](#)

- A fortified manor located in Vauvenargues, France.
- A property release is required for commercial use.

[Chatsworth House](#)

- A large country house located in Derbyshire, England.

- A property release is required for the shooting of the interior of Chatsworth House.

- Unacceptable for commercial use without a property release.

[Chicago Board of Trade](#)

- Established in 1848 and located in Chicago, Illinois.
- Unacceptable for commercial use.

[Chicago Navy Pier](#)

- A long pier on the Chicago shoreline of Lake Michigan with numerous entertainment attractions.
- Unacceptable for commercial use.

[Columbus Circle Globe](#)

- Located in front of the Trump International Hotel in Columbus Circle, New York, NY.
- Unacceptable for commercial use.
- Acceptable for editorial use with a proper caption.

[CN \(Canadian National\) Tower](#)

- Located in Toronto, Canada.
- Owned by the Canada Lands Company.
- Unacceptable for commercial use.
- Cityscapes will be considered, as long as the Tower is not the primary subject of the image. These images will be evaluated on a case by case basis.

[The Colosseum](#)

- Located in Rome, Italy.
- Exterior Images of the Colosseum are acceptable for commercial use.
- Interior Images of the Colosseum are unacceptable for commercial use.
- Exterior and Interior images of the Colosseum are acceptable for editorial use with a proper caption.

[Crazy Horse Memorial](#)

- Located in the Black Hills of South Dakota.
- The memorial is a monument in the form of a warrior, riding a horse and pointing into the distance.

- Unacceptable for commercial/editorial use.

[“Cupid’s Span” \(art installation\)](#)

- Located in Rincon Park (The Embarcadero) in San Francisco, California.
- Designed by Claes Oldenburg and Coosje van Bruggen in 2003.
- Unacceptable for commercial use.

[Dartmouth College](#)

- Located in Hanover, New Hampshire.
- The campus (including tower) are unacceptable for commercial use.

Dinosaur Museums

- The term “dinosaur museums” pertains to types of museums that have exhibits related to dinosaur fossils and models.
- Photos for personal use are allowed.
- Unacceptable for commercial use.

[Disneyland Resort](#)

- All Disneyland Theme Parks are unacceptable for commercial or editorial use.

[Eiffel Tower](#)

- Located in Paris, France
- Daytime shots are acceptable for commercial use.
- Images depicting the Tower’s lighting design are unacceptable for commercial use.

[Empire State Building](#)

- Located in New York City.
- Isolated images are unacceptable for commercial use.
- Cityscapes will be considered, as long as the building is not the primary subject of the image. These images will be evaluated on a case by case basis.

[Flatiron Building](#)

- Located in New York City.
- Isolated Images are unacceptable for commercial use.
- Cityscape images will be considered, as long as the building is not the primary subject of the image. These images will be evaluated on a case by case basis.

[The Fremont Troll \(aka 'The Troll' or the 'Troll Under the Bridge'\)](#)

- Public art located in the Fremont neighborhood of Seattle, Washington in the United States.
- The artists (Steve Badanes, Will Martin, Donna Walter, and Ross Whitehead) own the copyright and control commercial use of the Troll images.
- Unacceptable for commercial use.

[Frank Lloyd Wright Buildings](#)

- The architect Frank Lloyd Wright has designed numerous buildings in the United States as well as a few in Japan. Some of his most famous buildings are:
 - Robbie House – located in Chicago, IL.
 - Fallingwater – located in Mill Run, PA.
 - Johnson Wax Headquarters – located in Racine, WI.
 - Solomon R. Guggenheim Museum – located in New York City.
 - Taliesin – located in Iowa County, WI.
- Photography is only allowed for personal use.
- Unacceptable for commercial use.

- Getty prohibits commercial use of the Getty name and images of the buildings and gardens.
- Unacceptable for commercial use.

- Unacceptable for commercial use.

[Graceland](#)

- Home of Elvis Presley located in Memphis, Tennessee.
- Any commercial use must be cleared with Elvis Presley Enterprises, Inc. in writing in advance.
- Unacceptable for commercial use without written clearance.

[Grand Ole Opry](#)

- Located in Nashville, Tennessee.

- Unacceptable for commercial use.

[Grande Arche](#)

- Located in Puteauz, France.
- Unacceptable for commercial use.
- Editorial submissions will be considered with a proper caption.

[Grauman's Chinese Theater](#)

- Located in Los Angeles, California.
- The theater is property of Weststar Real Estate.
- Unacceptable for commercial use.

[Guangzhou Tower \(Canton Tower\)](#)

- Located in Guangzhou, Guangdong, China.
- Unacceptable for commercial use.
- Editorial submissions will be considered with a proper caption.

[Guggenheim Museum](#)

- Locations in New York City, Bilbao, Venice, Berlin, and Las Vegas.
- Property of the Solomon R. Guggenheim Foundation
- Unacceptable for editorial or commercial use.

[Hagia Sophia](#)

- Located in Istanbul, Turkey.
- Images containing the interior or exterior of the Hagia Sophia that are taken on the property are unacceptable for commercial use if they are not accompanied with a property release from an authorized representative of the Hagia Sophia.
- Images of the Hagia Sophia that are taken off of the property are acceptable for commercial use.
- Images containing the interior or exterior of the Hagia Sophia are acceptable for editorial use.

[Hearst Castle](#)

- Located in San Simeon, California
- The Hearst Castle is property of the State of California.
- Unacceptable for commercial use.

[Hollywood Sign](#)

- Located in Los Angeles, California.
- The sign itself is trademarked.
- Unacceptable for commercial use.

[Hollywood Walk of Fame](#)

- Located in Los Angeles, California.
- The Walk of Fame is a Hollywood landmark protected by trademark.
- Unacceptable for commercial use.

[ICEHOTEL](#)

- The world's largest hotel of ice & snow.
- Located in Jukkasjärvi, Sweden.
- Images are unacceptable for commercial or editorial use.

[Iolani Palace – Hawaii](#)

- Located in Honolulu, Oahu, Hawaii. It is currently a private museum managed by a non-profit, non-governmental organization.
- Images containing the interior and exterior of the Iolani Palace are unacceptable for commercial use due to Iolani Palace's photography policy.
- Images containing the Iolani Palace are acceptable for editorial use if they were taken off of the Iolani Palace's property.

- Unacceptable for commercial use.

- Unacceptable for commercial use.

- Unacceptable for commercial use.

[The “Lone Cypress”](#)

- Located in Pebble Beach, CA.
- On property owned and managed by the Pebble Beach Company.
- Unacceptable for commercial use.

[Longwood Gardens \(DuPont Gardens\)](#)

- Longwood Gardens is located outside Philadelphia PA, and sometimes referred to as the DuPont Gardens.
- This garden offers 1,050 acres of gardens, meadows, and woodlands. Only personal photography and video is permitted at Longwood Gardens.
- Unacceptable for commercial use.

[Louisiana Superdome \(aka “Superdome”, “The Dome”, or the “New Orleans Superdome”\)](#)

- Located in New Orleans, Louisiana
- Unacceptable for commercial use.

[The Louvre & IM Pei’s Pyramid](#)

- Located in Paris, France.
- The largest museum in France and one of the largest museums in the world.
- Both the Louvre & IM Pei’s Pyramid are trademarked designs.

- Unacceptable for commercial use.

[MAC – Museum of Contemporary Art](#)

- Located in Niterói, Rio de Janeiro, Brazil.
- The MAC building is copyrighted.
- Unacceptable for commercial use.
- Editorial submissions will be considered with a proper caption.

Manneken Pis

- Located in the city of Brussels, Belgium.
- Unacceptable for commercial use.
- Editorial submissions that contain the statue can be accepted for editorial use with a proper caption.

- Unacceptable for commercial use.
- Editorial submissions will be considered with a proper caption.

- Isolated images of the wheel are unacceptable for commercial use.
- Cityscapes will be considered, as long as the Wheel is not the primary subject of the image. These images will be evaluated on a case by case basis.

- Images are only acceptable as editorial with appropriate editorial captions.

[Minneapolis Sculpture Garden](#)

Modern Buildings

- Images of isolated buildings with modern or recognizable architecture are unacceptable for commercial use.
- Acceptable if they are a part of a skyline.

- Unacceptable for commercial use.
- Images are only acceptable as editorial with appropriate editorial captions.

[Monticello Estate](#)

- The Monticello Estate is located in Virginia.
- Exterior & Interior shots are unacceptable for commercial OR editorial use.

[Monterey Bay Aquarium](#)

- Located in Monterey, CA
- Exterior & Interior shots (including animals in the exhibits) are unacceptable for commercial use.

[Museum De Heksenwaag](#)

- Located in the Netherlands.
- Images taken on the property are unacceptable for commercial/editorial use.

Museum Interiors

- Unacceptable for commercial use unless accompanied with a property release signed by an authorized representative of the establishment.
- Editorial submissions will be considered with a proper caption.
- Images of museum interiors that contain isolated artwork or artwork that is the main focus of the image are unacceptable for commercial or editorial use.
- Wide-shots of museum interiors where the artwork is not the main focus of the image, are acceptable for commercial use with a property release, or editorial use.
- We will evaluate these images on a case by case basis.

- Unacceptable for commercial use.

- You are welcome to take any photography on the galleries or grounds for personal use only.

- Images containing the exterior of the Peterhof Palace will be considered for editorial use if the images were taken clearly off of the Palace grounds.

- Unacceptable for commercial use.

- Prior permission and arrangement is required for any Commercial photography inside the Princeton grounds.
- Unacceptable for commercial use.

[Rosslyn Chapel](#)

- Rosslyn Chapel near Edinburgh is famous for being mentioned in “The Da Vinci Code” book and film.
- Only personal photography on the premises is allowed.
- Unacceptable for commercial use.

- Unacceptable for commercial use.

- Located in Santa Monica, California.
- Unacceptable for commercial use.

[Science World at Telus World of Science](#)

- Located in Vancouver, BC Canada
- Unacceptable for commercial use.

[Schonbrunn Palace](#)

- Former imperial summer residence in Vienna, Austria.
- Unacceptable for commercial use without an official permit.

[Seattle International Fountain](#)

- The Seattle International Fountain is located in the middle of "Seattle Center" located in Seattle, Washington.
- Unacceptable for commercial use without property release.

- A chain of marine mammal parks with locations in Florida, California, and Texas.
- Owned by Busch Entertainment Corporation.
- Images from the parks (including animals, shows, and attractions) are unacceptable for commercial use.

- Located in Vatican City
- Images (both interior & exterior) are unacceptable for commercial and editorial use.

[Shrine of Remembrance, Melbourne](#)

- Located in Melbourne, Australia.
- Unacceptable for commercial use without property release.

[Smithsonian Institution](#)

- Located in Washington DC.
- The world's largest museum complex with most of its facilities in Washington, DC.
- Shots of the Smithsonian building are unacceptable for commercial use.

[Sovereign Hill, Australia](#)

- An open-air museum located in Gold Point, Australia.
- Images that contain Sovereign Hill (including: Mines, Gold Museum, Sound and Light Show) are unacceptable for commercial or editorial use.

[Space Needle](#)

- Located in Seattle, WA.
- Isolated images are unacceptable for commercial use.
- Cityscapes will be considered, as long as it is not the primary subject of the image. These images will be evaluated on a case by case basis.

[Statue of Liberty](#)

- Located on Liberty Island in New York City. Acceptable for commercial use.

[Stanford University](#)

- Located in Stanford, California.
- Images taken on campus are unacceptable for editorial or commercial use.

[Swan Boats](#)

- The swan boats are located on the lake of the Boston Public Garden in Boston, MA.
- Unacceptable for commercial use.
